<p>Spread of Covid-19 Coronavirus</p>	<p>Attendees at organised performances</p>	<p>Capacity – Capacity of each space has been calculated to ensure social distancing is possible</p> <p>The main auditorium can accommodate a maximum of 36 with each row having a maximum of two households or six people. Only alternative rows can be used</p> <p>Foyer Capacity – In order to ensure social distancing at events the foyer will be allowed to accommodate a maximum of 3 households at any given time – one at the bar, one 3 meters away in the space to the right end of the foyer and one waiting in the vestibule. All other households will be either in the auditorium (seated socially distanced) or waiting outside in a socially distanced queue</p> <p>Queueing – All queues for performances will need to be outside the building. Queues for toilets will need to be tightly controlled and social distancing enforced.</p> <p>Seating – all audiences will enter the building one household at a time. This group will have the opportunity to go to the bar to purchase drinks and will then be seated in their socially distanced space in the theatre. They will not be able to wait in the foyer.</p> <p>Upon entry all audience members will be reminded of the rules and asked to sanitise using the provided materials. Where applicable they will be asked to put on their masks.</p> <p>Once all audience members are seated they will again be reminded of the rules prior to the commencement of the production. They will also be asked to remain seated</p>	<p>All attendees will be asked to not attend if they have any covid symptoms.</p> <p>Staff and volunteers will be empowered to challenge anyone appearing to have covid symptoms.</p> <p>Consideration will be given to the necessity of purchasing a non contact thermometer.</p>	<p>DR</p>	<p>1/9/20</p>	<p>Yes</p>

		<p>at the end of the show and at the interval to allow the House Manager to dismiss the audience one row at a time to avoid any household contact upon exit.</p> <p>Interval – The House Manager will give each row an opportunity to attend the bar / toilets during the interval. Only one row will be allowed to be in the foyer at any given time. The House Manager will use his/her judgement to control the flow of people and ensure social distancing is maintained.</p> <p>End of Performance – Each row will be dismissed one at a time to avoid any contact on the way out. The House manager will dismiss the groups one household at a time and will ensure there is room in the foyer before releasing the next group. Audiences will be asked to leave promptly and sanitise again on their way out.</p> <p>Masks – audience members will be asked to wear a mask at all times except - those who are exempt</p> <p>-When drinking or eating.</p> <p>Performers – the action in the show will take place at least 2m from the front row. Performers will be asked to not physically interact with the audience.</p>

		<p>Performers and groups will be kept separate from the audience at all times. From the time that audience begin to enter the foyer, all performers and groups will be asked to remain backstage.</p> <p>Backstage entrances and exits should be used to maintain separation from audience.</p> <p>Meeting audience members in the building will be strictly forbidden.</p> <p>Performers and Groups will be responsible for ensuring their personnel are in appropriate fixed teams or bubbles to maintain social distancing.</p>	performers to support those less familiar with RA process.			
Tech Crew	Spread of Covid-19 Coronavirus	<p>Minimal possible Tech crew will be used.</p> <p>Where possible performers / groups will provide their own crew from within their own bubbles / fixed teams</p> <p>Where Seagull volunteers or staff are used, they will maintain social distance from the performers and audience wherever possible.
